Recreation Committee Meeting

The Recreation Committee met on Monday, November 4, 2019 at 5:00 p.m. at 316 S. Brad Street, Grantsburg, WI.

Committee Chairman Muehlberg called the Recreation Committee Meeting to order at 5:00 p.m.

The Pledge of Allegiance was recited.

Discussion/Action: Community Center Rules, Rates & Uses. The committee discussed uses for the Community Center with Kathy Lund, Grantsburg High School Gymnastics Coach. The Grantsburg School rents the Community Center from mid-November – mid-March for the high school gymnastics program. When the center is rented for other activities, the gymnastics equipment is taken down and stored in a storage room. This is a huge task and causes wear and tear on the equipment. The committee would like to minimize the number of times this is needed while still making the center available for the community to use. A partition was discussed. This would leave a small area on the south end of the center for rentals during the week. Clerk/Treasurer Meyer was asked to contact Josh Watt, School Superintendent, regarding the possibility of the Village and the School cost sharing for the purchase of a partition. Lund indicated that it would be helpful if the full center was not rented during the week, Monday – Thursday to minimize the need to take down the equipment. Lund left the meeting. The committee made several changes to the Community Center Rental Agreement. **Motion by Trustee Barton, second by Trustee Roberts to recommend the Village Board approve the Rental Agreement for the Community Center/Meeting Rooms as amended. Motion carried.**

Discussion/Action: Community Center Rental Agreement with Grantsburg School District. The committee reviewed the 2019 Long-term Rental Agreement between the Village and the Grantsburg School District. **Motion by Trustee Roberts, second by Trustee Barton to recommend the Village Board change the long-term rental rate to \$7.00 per hour and change the monthly rental fee for Storage Room #2 to \$100 per month. Motion carried.**

Discussion/Action: Skating Rink Rules, Concession Schedule, Signage. The committee made several revisions to the skating rink rules. **Motion by Trustee Barton, second by Trustee Roberts to recommend the Village Board approve the skating rink rules as presented. Motion carried.**

Discussion/Action: Adjournment. **Motion by Trustee Barton, second by Trustee Roberts to adjourn the meeting at 6:30.**
