Property Assessment Notice

You may notice someone at your property from Bowmar Appraisal, Inc., the Village's assessor. The Village is currently in year two of a three-year revaluation. WI State Statutes require a municipality's total assessed value be within 10% of full value (equalized) at least once within a five-year period. If a municipality is non-compliant after four consecutive years, a revaluation is required. Homeowners will receive a notice of changed assessment in the spring of 2025 and will have an opportunity to speak with the assessor at that year's Open Book and/or Board of Review. New assessed values will be in place for the 2025 tax roll. (tax bills mailed in December of 2025).

VILLAGE DRINKING WATER UPDATE

The pilot studies at Wells #1 and #2 have been completed. These studies ran from December to March and will help determine the next course of action in treating manganese at these two wells. The Village is waiting for the final report from these studies which will be shared at monthly board meetings and detailed in these quarterly notices as the information becomes available.

A public notice was placed in the March 27th edition of the Burnett County Sentinel. This notice will be issued quarterly until manganese levels at Well #1 and Well #2 are below the 300ug/l limit set by the EPA. The Village Crew continues to test manganese levels 3 times per week throughout the distribution system and those manganese levels continue to remain below the 300ug/l limit. This means that the water available to drink throughout the distribution system meets EPA safe drinking water standards. The fill station at the Village Office continues to be available for residents. The fill station's most recent results show manganese levels at 1ug/l. If you have any questions, please contact the Village Office for further details.

REPORT NUISANCE BEARS!

Please report all nuisance bears to USDA-Wildlife Services in Rhinelander 1-800-228-1368. Keep garbage and recycling containers in your garage or



secured building until garbage/recycling day. Remove all bird feeders and wildlife feed by the middle of April. By working together to reduce/eliminate food sources, we can discourage bears from coming into the Village.

HELP KEEP OUR STREETS CLEAN!

Debris and other litter that are in the streets are often washed down the storm sewers and eventually find their way to Memory Lake, the St. Croix River, and our watersheds. The Public Works Crew utilizes a street sweeper to gather some of the debris to minimize the amount that is washed down

the storm sewers. Please do your part, too, and keep streets, alleys, and gutters near your home or business free of leaves, grass clippings, twigs, branches, or litter to limit the amount of unwanted debris in our waterways.



SPRING HYDRANT FLUSHING

The Public Works Crew will be flushing fire hydrants in April. Hydrant flushing is necessary to make sure adequate flow and pressure is available

and to remove sediment from the pipes. Occasionally, water may become discolored after hydrant flushing. If this happens, run your cold water tap for a few minutes until the water clears. If the water does not clear the first time, wait a few minutes, and run the water again. Avoid washing clothes until the water clears. If you have questions or concerns, please contact the Public Works Department.
